- 1. Parking Lot Seal Coating and Patching
 - a. Eddie gave the update on the proposal from Hastings Asphalt Services. We are locked in on the seal coating from 2018 as it got too late to do the work.
 - b. For the patching work we have 4 locations in the main parking lot to get repaired around 650 square feet. The price came in at \$2,540, this work is slated for next week.
- 2. Private Event Schedule
 - a. Eddie provided an overview of the requirements of having an event in the club house, which is \$250 per event, food can be catered from a list of approved vendors, all beverages have to be purchased through the bar.
- 3. Slip Sales
 - a. Eddie gave an update of the slip sales. We have two closing in the next couple of weeks. At this time there is only one slip available. An AA Slip for \$189,000.
- 4. Water Circulator Electrical Charge

- a. Eddie had an owner approach him about slip holders having water circulators in the slip and letting them run continuously since the season opened.
- b. The board decided to leave everything as status quo and not charge slip holders for electricity. The benefits of having the water moving greatly outweighs the cost of running the pumps.
- 5. Harbor Work Boat
 - a. The 1979 Mako Center Console needed a number of repairs to the oil reserve, oil line, engine rehab, in addition to that the boat had sunk 3 times last season.
 - b. In speaking with Mark from Jerry's Majestic Marine it was discussed that the boat is not worth putting the money into.
 - c. Eddie and Dave have met with the boat companies that own slips in the Abbey Harbor and have provided a cost summary of a new boat.
 - d. Craig suggested we hold off on purchasing a new boat and investigate possibly buying a used boat if we can find one that will suit our needs.

<u>Prudden/ Kohnke 2nd a MOTION to table action on this until the next board meeting or we find a used</u> boat that suits our needs, and the MOTION carried by ayes without a negative vote.

- 6. Pool Update
 - a. Craig and Eddie are going to meet with Ramaker next week to execute the agreement. Our plan is to have a plan and renderings ready for the May meeting. We are also going to have a consult with Sean Gallager from Poolblu after this meeting.
- 7. Intended Usage Agreement Unit 701
 - a. When the AH Slips were installed the unit owners of 701 would like to have the option to stay using the slip that is against the main walkway. This agreement will serve as the instrument until they decide to sell the slip.

- 8. 16' Access Easement Relocation
 - a. Warren Hansen and Association created a document to relocate the 16' Access Easement for the Ice House. We will need this in order to proceed with the pool.

- 1. Harbor Projects
 - a. Craig gave a brief update on the close out of the Harbor Renovation project. He touched on the various awards that we won in 2018 including the Building and Growing award through Marina Dock Age, Ed Jr Young Leader Award through Marina Dock Age, and a Concrete Design Award from the Wisconsin Ready Mix Association.
- 2. Boat Lifts
 - a. Dave presented an alternative to the floating lifts that we have in the harbor with a shore station that will work with our soil conditions. There was a handout from Sunstream Boat Lifts that we would like to see moving forward.
 - b. These lifts will be able to go in all 3 size slips in the harbor.
 - c. We are going to further investigate the cover option that we currently have on one of the floating lifts to see if we will allow those on the stationary lifts. We will not allow awnings or Bimini top covers like you see on the lake.
- 3. Harbor House Pool
 - a. Craig gave a project overview of the new pool and pavilion that we are proposing for the Fall 2019/ Spring 2020. We have done all of the engineering and design, permits have

- been applied for and we have the meeting date set with the state for permit review, bank financing is in place for up to \$600,000.
- b. Craig also discussed that we will be offering up the naming rights to the pavilion as well as selling engraved pavers to raise capital for the pool project to help off-set some of the costs.
- c. H. Granat asked what the timing would be for the project. Craig responded that demo will start in September and the project will wrap up in the Spring prior to Memorial Day.
- d. B. Hammen asked is a hot tub was discussed. We did discuss putting in a hot tub and ultimately it did not fit within the scope of the project.
- e. S. Prater was a saltwater pool considered? Yes, however, there were other obstacles with a saltwater pool with the type of loading that we have. We are not able to turn the pool over fast enough with a saltwater pool.
- f. B. Webster asked if a special assessment was discussed or on the table should this not pass. A special assessment was not on the table. We are able to fund this with money in the operating and improvement accounts along with taking out a loan. The loan will be paid out of the annual operating budget.

Question and Answer

- P. VanKuiken- Has the association looked into fundraising for other charities outside of COS?
 - We have done fundraisers in the past for Inspiration Ministries in the past. We will look into this at budget time.
- A. Landau- Has the board looked into doing a reserve fund study?
 - o No, but we will work on that over the fall and winter months.
- P. VanKuiken- Do we make money off the wood boat show? It seems like an awful big inconvenience for the staff and not sure the expenses are justified.
 - We do make money off the wood boat show. It is also a goodwill event for the Fontana Community.
- K. Lange- Do we make money off Gordy's running there in and out operation through the harbor?
 - We will have to look at this at the September meeting.
- L. Hummel- Does the board anticpate any other projects coming down the pipeline that would require another special assessment?
 - o No, we don't have any other plans at this time outside of the pool.
- E. Breen- Why doesn't Gordy's support the pool project?
 - o N. Polce responded with Gordy's does not want to add any more debt to the association.
- D. Svarc- Can we put a bulletin board up in the Harbor House so owners can post stuff?
 - o The board will review the request and look into it next month.
- S. Prater ask if we thought the taxes would go up with the pool project?
 - O No, we don't think there will be a large increase to the taxes for the pool project. The slips on the other hand will see an increase with the values in recent sales.

Pool Renovation Vote

Pool Renovation Vote passed 202 Yes Votes to 176 No Votes in favor of the proposed Abbey Harbor Pool Improvement Plan, including but not limited to a loan with Barrington Bank and Trust up to \$600,000 which will be paid out of the Operating Account.
